

Waiver of Liability and Assumption of Risk

Note: This is a legally binding Agreement. Do not sign this Agreement until you have read it carefully and understand its contents. This Agreement may affect, reduce or eliminate your legal rights in certain circumstances. This Agreement must be signed by you.

I hereby request permission to participate on a BNSCP delegation including travel to and from BNSCP Delegation locations via transportation arranged by BNSCP or partners in the region. [The Delegation will begin and end in Jerusalem, all delegates are expected to arrive to Jerusalem of their own accord. Assistance with ground transportation to or from Jerusalem will be provided, at an additional charge, only if requested.]

I agree as follows:

- 1. I will secure a passport and/or any visas necessary for foreign travel to Nablus.
- 2. I am aware that BNSCP cannot guarantee me access to the country; Israeli security can and does deny entry to international travelers for various reasons and without explanation.
- 3. I am aware that there is a chance personal items, including computers, mobile phones, and purchases I make while in Palestine could be confiscated by Israeli security (although unlikely).
- 4. BNSCP reserves the right, at its sole discretion, to make changes in the itinerary whenever changes are warranted or deemed appropriate and withdraw participation of any delegation member whose conduct is incompatible with the group or mission of the BNSCP.
- 5. I understand that the delegation, including hiking on Masar Ibrahaim, and/or other outdoor farming, touring, and sightseeing activities, can be somewhat physically difficult. I will disclose to BNSCP any physical conditions that may affect my participation in the delegation. (an alternate program will be arranged for those unable to participate in hiking from village to village).
- 6. I agree to fully comply with all rules and regulations established by the group leaders for the conduct of Participants on the Delegation, including, without limitation, the BNSCP Standards of Personal Conduct and Community Behavior (the "Standards"). I confirm that I have read the Standards and understand them in their entirety. [See page 11 of this packet]
- 7. If the delegation leader(s) determines in their sole discretion that my conduct fails to comply with the Standards or discredits the status or reputation of BNSCP, I will withdraw from the



Delegation and, if the delegation is already underway in Palestine, I will return to my home residence when directed to do so by the leaders. I will also pay any outstanding costs (such as hotel charges) immediately upon receipt of a written request for payment from BNSCP.

- 8. I understand that I alone am responsible for any medical costs while on the delegation, including but not limited to, doctor's visits, medication, and special medical travel arrangements. [discounted international travel insurance is available and highly recommended: http://sistercities.org/insurance]
- 9. I understand that I have the option to pay in full upon being accepted to the delegation or requesting a payment schedule divided into 3 equal payments. Final payment is due no later than January 6, 2019. The non-refundable deposit of \$250 is due along with this application. I further understand that the international airfare is not included in delegation fees and I will purchase this separately.
- 10. If cancellation is received in writing before Jan. 1, 2019, a \$250 fee applies plus unrecoverable deposits, accommodation, travel, or other payments. After Jan. 1, a \$500 cancellation fee will be deducted from your refund, due to the special contracts, commitments to other delegates, and the services rendered on behalf of the entire delegation. Travel insurance is highly recommended.
- 11. If I depart from Nablus on a date other than that originally scheduled. I agree to pay any additional travel costs and other expenses incurred by BNSCP.
- 12.I understand that in the rare case of Israel denying my entry to the country, that BNSCP will use its best efforts to recover ground expense, such as unused lodging and meal costs, so that a portion of the fees I have paid may be returned to me. I understand that BNSCP cannot guarantee the return of any fees in the case of denied entry.
- 13.I agree to allow BNSCP to use my name, written or oral quotations and/or photograph in marketing and promotional materials, including, but not limited to, Facebook posts, presentations, brochures, posters, flyers, and websites. [Please cross this out if you do not wish to appear in these promotional materials]
- 14. I also hereby release, discharge and agree to hold harmless BNSCP, their members, directors, and officers, agents, host country sponsors and other participants in the Delegation from any and all liability, claims, demands, rights or causes of action, brought on my own behalf or by or for any other person, or by my heirs, executors, or assigns, for



personal illness, injuries or death, denial of entry, or any damage to or loss of personal property which may occur en route to, during, from or as a result of my participation in the BNSCP Delegation to Palestine.

- 16. In signing this document, I expressly release, discharge, and hold harmless BNSCP and the persons described above to the maximum extent permitted by law in any state, territory, district or country.
- 17. Note: By signing my registration application, I affirm that I have been advised and am aware of the U.S. State Department Travel Warning to Israel and the West Bank (http://www.travel.state.gov/travel).
- 18. I have read the foregoing and sign it voluntarily. I am of sound mind and act of my own free will, without coercion or duress, in signing this Waiver of Liability and Assumption of Risk.

Standards of Personal Conduct and Community Behavior

Note: We ask delegates to make a few basic commitments prior to, during, and upon return. Please indicate your general agreement by signing your name or briefly explaining any reservations you have beside the corresponding item.

The BNSCP Delegation participant will:

- 1. Attend a required orientation meeting prior to departure. Trip leaders will schedule this on a date and time that works for most delegates. Those unable to attend will be required to arrange an alternate time in which to receive critical delegate information.
- 2. See themselves as a member of a group, abiding by the decisions of the delegation coleaders. This may mean putting aside personal preferences; delegation leaders are more familiar with cultural cues, always seeking to honor and respect local hosts.
- Attend and be punctual at meetings of the delegation unless extenuating circumstances
 prevent you, in which case you will be expected to notify a delegation leader of your
 absence in advance of the meeting (whenever possible).
- 4. Consult with the delegation leaders about arranging meetings with friends or additional contacts to make sure that they do not create scheduling or logistical conflicts.
- 5. Act in the spirit of respect for behavior, values, and customs of another culture throughout the trip, putting aside American expectations whenever possible. [When in doubt ask delegation leaders for guidance]

The BNSCP Delegation participant will not:

- 1. Engage in any behavior that may be harmful to the health and safety of yourself or others, nor will the Participant engage in any behavior that may be detrimental to the group.
- 2. Make promises or even hint at the possibility of a future project to any local individual. [Please understand that your heart may be tugged multiple times over the course of the visit and you may feel inspired to begin a project upon return to the US. All projects must be presented via proposal to the BNSCP board of directors for approval, therefore you are encouraged to take notes as you gain ideas, but in no way are you to communicate these ideas with people you meet in the course of the delegation. Further explanation will be given at the required orientation meeting prior to the delegation's departure.]
- 3. Offer any advice to those you meet. You may well have brilliant ideas of how to resolve the current political situation, and unless these ideas are invited at the initiative of our hosts,



you are NOT to make any suggestions to anyone about what they 'should' or 'could' do differently. Delegates are there to make friends and good friends do not offer advice unless it has been solicited.

- 4. Use or possess any drugs which are illegal under the laws of the US or Palestine.
- 5. Consume alcoholic beverages when it's culturally inappropriate to do so (Nablus is 'dry', you, therefore, should plan not to partake of alcoholic beverages during the delegation).
- 6. Go anywhere by themselves without first informing a delegation leader (this does not include scheduled 'free time' for delegates).
- 7. Handle firearms or any other type of weapon.
- 8. Engage in sexual activity with local community members. [Palestinian culture is far more conservative than we are accustomed to and thus even flirting or sexually suggestive language/jokes/innuendos are disrespectful and to be avoided.]

Each BNSCP Participant should understand that the following rules apply during all phases of delegation participation.

Procedures in the Event of a Violation of the Standards

An infraction or disregard for the Standards of Personal Conduct and Community Behavior may result in the Participant's immediate dismissal from the Delegation and return to the United States, country of origin, and/or home residence at the expense of the Participant.
