Chair Elect Sister Cities International Board of Directors

After service as Secretary and Member of the Board of Directors of Sister Cities for nine years, in August of 2018, Carol was elected Vice Chair and Chair Elect of Sister Cities International. Previous to serving on the Board, Carol was a State Coordinator/Representative for New Mexico and was also appointed to the SCI Honorary Board.

At the local level, she serves as the Chair of the Santa Fe Sister Cities Committee and her passion has been the Bukhara/Santa Fe Sister Cities.

She is a recent Past President of the International Women's Forum-New Mexico. Carol is the immediate Past President of the American Women for International Understanding and recently returned from an AWIU delegation to Ethiopia. Carol is an active member of the International Women's Forum having served as President of New Mexico's Chapter.

Carol is currently serving as the Executive Director of the New Mexico Children's Foundation. She has been a member of the Board or Advisory Board of the Santa Fe International Folk Art Market since its creation. This Market is juried and for 16 years, the number of artists from Uzbekistan have been second because of the incredible quality of the work. Only neighboring Mexico has a greater number of artists.

Carol served two terms on the Santa Fe City Council and six as Mayor ProTempore. In addition to Chairing Public Works, Finance and Public Safety, a major accomplishment was the securing the funds for the building of the Southside Library. She served as President of the New Mexico Municipal League and traveled extensively throughout New Mexico in her positions. She chaired the International Council for the National League of Cities.

Carol served a long career in various administrative positions in state government including: the New Mexico Department of Transportation, the Office of the Attorney General in Santa Fe, the State Personnel Office, and the State Planning Division. She received the 2004 Governor's Award for Outstanding New Mexico Women. While engaged in these positions she worked with the NM State Legislature and continues to do so on behalf of the IFAA and Museum Hill Partnership.

Carol has traveled numerous times to Uzbekistan and the government of Bukhara and Uzbekistan with the title "Honorary Citizen of Bukhara." She cut the ribbon for the Silk and Spices Market and spoke at the International Conference on Tourism in Bukhara. She also monitored elections in Uzbekistan twice.

Carol has completed all coursework for a Ph.D. from New Mexico State University in higher education management and also earned her Master's Degree from New Mexico State University. Her passion is travel and learning about the world with her husband Jeff, a former Peace Corp Volunteer. She gardens, swims and is an avid reader.

Carol has been a member of the Milagro Community Garden for the last ten years where her tomatoes have twice won blue ribbons.
